- reinstalling a piece of machinery or equipment incorrectly installed on your customer's premises
- reimbursing your customer for loss of use or lost production time resulting from your defective product or faulty installation

Coming to your defense

To defend you against a covered claim, we pay legal fees in addition to your Manufacturers' E&O Coverage limits.
